I wish to invite you to participate in my research project, described below.

My name is Tahira Haider and I am conducting this research as part of my Doctor of Philosophy (Clinical Psychology) thesis in the School of Behavioural, Cognitive and Social Sciences at the University of New England. My supervisors are Associate Professor Debra Dunstan and Dr Navjot Bhullar.

Research Project	Identifying barriers and facilitators impacting psychologist practice in treating secondary psychological injuries within the State Insurance Regulatory Authority governed insurance frameworks.
Aim of the research	The aims of the research are: to identify barriers to psychologist's use of evidence based practice; to propose strategies to overcome these barriers; and, to explore whether client characteristics may impact psychologist practice and treatment of psychological injuries.
Focus Group Interview	I would like to conduct a face-to-face focus group interview with you. The focus group interview will take approximately two hours. With your permission, I will make an audio recording of the interview to ensure that I accurately recall the information you provide. Following the focus group interview, a transcript will be provided to you if you wish to see one. For participating in the discussion, you will receive lunch and \$50.
Confidentiality	Any information or personal details gathered in the course of the study will remain confidential. No individual will be identified by name in any publication of the results. All names will be replaced by pseudonyms; this will ensure that you are not identifiable. If you agree I would like to quote some of your responses. This will also be done in a way to ensure that you are not identifiable.
Participation is Voluntary	Please understand that your involvement in this study is voluntary and I respect your right to withdraw from the study at any time. You may discontinue the interview at any time without consequence and you do not need to provide any explanation if you decide not to participate or withdraw.
Questions	The interview questions will not be of a sensitive nature: rather they are general, aiming to enable you to enhance my knowledge of the challenges and opportunities facing insurers whilst managing secondary psychological injury claims.
Use of	I will use information from the focus group interview as part of my

information | doctoral thesis, which I expect to complete in 2018. Information from the interview may also be used in journal articles and conference presentations before and after this date. At all times, I will safeguard your identity by presenting the information in a way that will not allow you to be identified.

Storage of information | I will keep electronic copy of the notes and recordings of the interview on a password-protected computer in the University of New England's School of Behavioural, Cognitive and Social Sciences. Only the research team, which includes my supervisors and myself will have access to the data.

Disposal of information | After the successful submission of my thesis, I will hand over all the data collected in this research to my principal supervisor. The electronic data will be kept indefinitely (for future research/teaching purposes) by the principal researcher.
