



Pfizer 12 years+ (Purple) – Vaccine Shelf-Life Extension

Dear COVID-19 Vaccination Partner

The Therapeutic Goods Administration (TGA) has approved a shelf-life extension of **Comirnaty Pfizer 12 years+** (**Purple**) from 12 months to 15 months from the manufacture date.

NOTE that the extended expiry date DOES NOT replace the thawed use-by date for vaccines, which remains at:

• 31 days from the thaw date for Pfizer 12 years+ (Purple)

It is vital that sites are aware of the differences between the extended expiry date and the thawed use-by date, which are both applicable for mRNA vaccines:

- The extended expiry date indicates the shelf-life for the vaccine while stored in the freezer or ultra-low temperature storage.
- The thawed use-by date is the use-by date for vaccine that has been thawed. This commences at the time the vials are removed from the freezer or ultra-low temperature storage.

Prior to administration, both the extended expiry date and thawed use-by date should be checked and the earliest of these dates should be considered the expiry date. Please ensure your site has clear processes to identify and action these dates to prevent vaccine administration errors.

Please reference the below table for existing **Pfizer** vaccine stock, as well as when receiving new orders, for the extended expiry date. The packaging associated with the below batches has not been amended to reflect the shelf-life extension. Please update the expiry date on the packs and vials to reflect this change. The new expiry date of each batch will also be shown in CVAS when completing delivery acceptance.
